Martin Midstream Partners L.P. Announces Incremental Revolving Credit Capacity

(Nasdaq:MMLP) ("MMLP" or the "Partnership") announced today that it has increased the size of its revolving credit facility to \$400,000,000. This represents an increase of \$25,000,000 as the Partnership has added ABN AMRO Capital USA LLC to its syndicate of lenders for that amount. The revolving credit facility is the Partnership's primary source of liquidity and matures April 15, 2016.
