Martin Midstream Partners Announces Increased Quarterly Cash Distribution and Release Date of First Quarter 2014 Results

KILGORE, Texas, April 23, 2014 (GLOBE NEWSWIRE) -- Martin Midstream Partners L.P. (Nasdaq:MMLP) announced today it has declared a quarterly cash distribution of \$0.7875 per unit for the quarter ended March 31, 2014 and plans to publicly release its financial results for the first quarter ended March 31, 2014 after the market closes on Wednesday, April 30, 2014.

In addition, Martin Midstream Partners plans to file its quarterly report on Form 10-Q for the fiscal quarter ended March 31, 2014 after the market closes on Monday, May 5, 2014.

This quarterly distribution increase is \$0.0025 per unit higher than the distribution paid in the prior quarter. The distribution is payable on May 15, 2014 to common unitholders of record as of the close of business on May 5, 2014. The ex-dividend date for the cash distribution is May 1, 2014. This distribution reflects an annualized distribution rate of \$3.15 per unit and is based on Martin Midstream Partners' current and expected operating performance and the current general economic, industry, and market conditions affecting it.
