



## **Martin Midstream Partners Announces Quarterly Distribution and Release Date of Third Quarter 2011 Results**

KILGORE, Texas, Oct. 26, 2011 (GLOBE NEWSWIRE) -- Martin Midstream Partners L.P. (Nasdaq:MMLP) announced today it has declared a quarterly cash distribution of \$0.7625 per unit for the quarter ended September 30, 2011 and plans to publicly release its financial results for the third quarter ended September 30, 2011 after the market closes on Wednesday, November 2, 2011.

In addition, Martin Midstream Partners intends to file its quarterly report on Form 10-Q for the quarter ended September 30, 2011 after the market closes on Monday, November 7, 2011.

### *Quarterly Cash Distribution*

This quarterly distribution remains unchanged from the distribution paid in the prior quarter. The distribution is payable on November 14, 2011 to common unitholders of record as of the close of business on November 7, 2011. The ex-dividend date for the cash distribution is November 3, 2011. The August distribution is based on the current operating performance of, and the current general economic, industry and market conditions impacting Martin Midstream Partners and reflects an annualized distribution rate of \$3.05 per unit.
